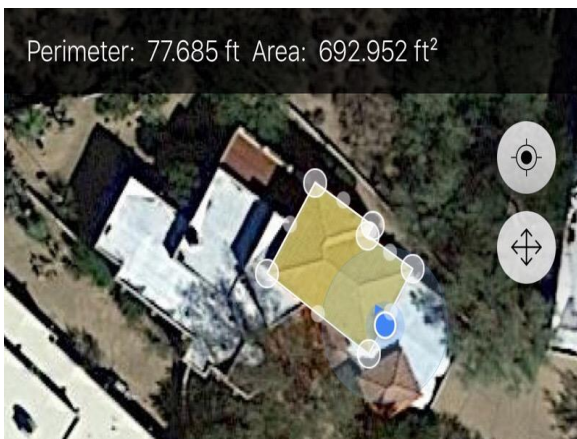
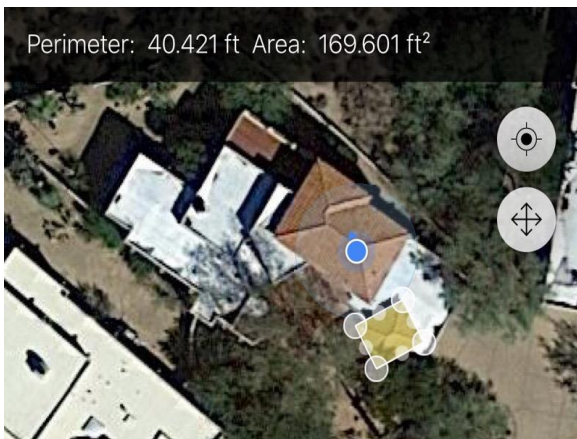

### Skylights and Solar Tubes

We are not responsible for damage to interior of home underneath skylights. If skylights need to be removed as part of the scope of work it is the home owner's responsibility to put down a towel, blanket, plastic, etc. Payne Roofing is not responsible for cleaning up the debris that may fall inside the unit. The skylight(s) may be removed several times throughout the project without any notice or warning. Payne Roofing will clean the outside of the skylight but it is the home owner's responsibility to clean the interior.

### Gutters

Payne Roofing does not do gutters. We do not disconnect them or re-install them. We are not responsible for damage to them. A licensed gutter contractor will need to remove the gutters before we begin the project and can return to install them after the project has been completed. Payne Roofing is not responsible for this expense. The original framing, structure of the roof may change for whatever reason and the gutters may be too big or small, Payne Roofing is not responsible for any adjustments needed to the original gutters.

### Water Heaters and Solar Panels

Payne Roofing does not do Water Heater panels or Solar Panels. We do not disconnect them or re-install them. We are not responsible for damage to them. A licensed water heater/solar contractor will need to remove them before we begin the project and can return to install them after the project has been completed. Payne Roofing is not responsible for this expense. Payne Roofing is not responsible for any adjustments needed to the original scuppers.

### Satellite Dishes

Payne Roofing is not responsible for your satellite dish. If the dish has to be removed and/or disconnected for the project, your provider will have to come out and re-locate the dish. The dish may not be re-installed at its original location due to the voiding of the warranty provided by Payne Roofing. The only locations accepted by Payne Roofing is at the eaves directly into the fascia board. The other approved location is on any flat roof with a stand and cinder blocks. If they satellite provide penetrates any of our roofing systems with a fastener, lag bolt, etc. the warranty will void and the home owner will be responsible for any repairs need to rectify the situation.

### Wood Replacement

During the roof repair/replace process, our roofing crews will be able to ascertain the condition of the wood decking and framing underneath the roofing system. If this wood is found to be damaged, rotted, or unusable in any way it will be replaced to ensure proper installation of the new roofing materials. We cannot and will not install or warranty new roofing materials on damaged wood. The additional cost of wood replacement is not something that can be estimated during the initial inspection/estimate due to it being concealed damage. If damaged or rotted wood is found and replaced during the project, the dollar amounts that will be charged for wood replacement are listed in the Payne Roofing Wood Price List below.

- In the event of legal action, I/we agree to pay reasonable attorney fees, court costs, and collection fees.- This proposal shall be open and binding on contractor for a period of thirty (30) days from the date stated above. If after thirty days the owner accepts said contract, the contractor reserves the right to modify the terms of this contract to reflect any price increases in material and labor.

We do not reinstall satellite dishes on the roof. We cannot be held responsible for operating condition.
